

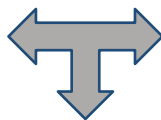

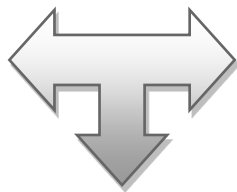

3. Form of certification of applicants for higher education.
